**Demolition Services Request for Bids for demolition of the Buffalo Memorial Auditorium**

**Description:**

The Erie Canal Harbor Development Corporation (ECHDC) is seeking bids from Contractors for the demolition of the Buffalo Memorial Auditorium (Aud). Currently the ECHDC has contracted for the removal of Universal/Household Hazardous Waste and Asbestos Abatement within the structure. Bid Documents are being prepared by C&S Engineers, Inc. The Aud was constructed in 1939 with major renovations occurring in 1970 and 1990. The work will consist of the demolition of the Aud in it's entirety with the legal off-site disposal of all debris as directed by the ECHDC and City of Buffalo. Empire State Development Corporation's (ESDC) Non-Discrimination and Affirmative Action policy will apply. The Contractor shall be required to use it's best efforts to achieve Minority/Woman owned Business Enterprise (M/WBE) participation of not less than 20/5% respectfully of the total dollar value. All respondents to this procurement will be required to comply with ESDC's Terms and Conditions (Schedule A) and insurance requirements as spelled out in the contract documents. Respondents will also be required to comply with the State Tax Law Section 5a and State Finance Law 139j-k which are included in the schedule A.
